Background

The High-Level National Round Table "GREEN ECONOMY. Made in Moldova" is organized within the EU funded Action EU4Environment, as follow-up to the EU funded "Greening Economies in the Eastern Neighbourhood" project (hereinafter EaP GREEN). EU4Environment is jointly implemented by EU, OECD, UNECE, UNEP, UNIDO and the World Bank and coordinated by the Ministry of Agriculture, Regional Development and Environment and Ministry of Economy and Infrastructure. Important components of EU4Environment are supporting Green economy ownership, policy coherence and cross-sectorial coordination.

The High-level National Round Table for the promotion of Green Economy is coordinated by the Inter-ministerial Working Group on Sustainable Development and Green Economy/EU4Environment National Implementation Committee, co-chaired by the Ministry of Agriculture, Regional Development and Environment and Ministry of Economy and Infrastructure. The event is organized in partnership with Chamber of Commerce and Industry of the Republic of Moldova and the Public Association EcoContact with support from UNEP.

The **I-st** Round Table was organised in 2016 within EaP GREEN, consecutive meetings (2-4th) took place yearly, and the fifth event is taking place in 2020.

Meeting objectives, expected outputs and outcomes

- Reaffirm "Made in Moldova" as a platform for the promotion of Green Economy principles for local producers, partners and visitors of the exhibition;
- Promotion of the Green Economy Concept at the highest political level, in all socialdevelopment sectors of the country, attracting the private sector, development partners, NGOs, media and the general public;
- Presentation of the contribution of EU4Environment to the implementation of the Green Economy principles, Environmental Strategy 2014-2023 and Program on the promotion of Green Economy in the Republic of Moldova for 2018-2020;
- Increasing awareness of stakeholders from businesses and enterprises, governmental agencies and the general public on the application and benefits of the Green Economy principles for sustainable economic development;
- Receive suggestions from different actors, including business representatives, for policies or actions for possible integration into the Green Economy promotion process at national level.

Participants

Invited participants to the Round Table will include representatives from governmental agencies, international organizations, embassies, businesses and enterprises / private sector, academic sector, environmental NGOs and experts, mass-media.

Simultaneous interpretation in Romanian and English will be provided.

The event will take place in Green meeting/paper less format.
