### SMEs have been at the epicenter of the COVID-19 pandemic


Across the world, 180 SME surveys show...




Over 70-80% of SMEs experienced a strong drop in revenue of between 30-50%



40% of SMEs stopped operating during the pandemic







#### Twin transitions: SMEs and net zero

- SMEs account for 60-70% of GHG emissions and industrial waste...
- ...and can contribute significantly to eco-innovation
- Lack of data and clarity on (drivers of) SME greening
- Support for SME greening central position in the EU SME Strategy but different approaches in SME&E policies across EU/OECD countries

- What policies are best suited to support green entrepreneurship and the SME transition to net zero?

#### Twin transitions: SMEs and digitalisation

- Although COVID-19 has provided a strong push for SME digitalisation, in particular ecommerce...
- ...SMEs continue to lag behind in the adoption of digital technologies...
- ...and face significant challenges (cyber security)
- Governments have increasingly included measures for SME digitalisation in support packages...
- ...but will these sufficiently take the different needs of the heterogeneous SME population into account?
