Inception Consultation Workshop in Ukraine

Background

The United Nations Environment Programme (UNEP) is one of five partner agencies implementing an EU-funded EU4Environment Programme (2019 – 2022). This regional programme supports the Eastern Partnership (EaP) countries (Armenia, Azerbaijan, Belarus, Georgia, the Republic of Moldova, and Ukraine) in making policy planning and investment greener, stimulating the uptake of innovative products and technologies, and raising awareness about benefits of environmental action. The application of strategic approaches to waste management can assist in addressing countries' overarching waste management challenges. To this end, within EU4Environment's component 2.4 on "The use of strategic approaches on waste management" UNEP supports countries in promoting development of comprehensive sustainable waste management policies and policy instruments. More specifically, under *Activity 2.4.2 Initiating/assisting the establishment of Extended Producers Responsibility (EPR) schemes*, UNEP provides technical assistance to partner countries in the establishment of EPR schemes for the packaging waste streams. This will be achieved through the provision of advisory services and capacity development/trainings to policy makers, businesses and business associations, as well as Civil Society Organizations (CSOs) and other stakeholders.

To this end, UNEP, in collaboration with the implementing partners, is organizing the Online Consultative Working Group Meeting in Ukraine. The meeting aims are to present the preliminary findings of the draft recommendations report for the elaboration of a draft packaging waste law in Ukraine, present and discuss the needs and priorities and agree upon the next steps for developing an effective EPR scheme in the country.

Meeting objectives, expected outputs and outcomes

- Present the findings for Ukraine from the draft regional analytical report.
- Discuss and present the preliminary findings of the draft recommendations report for the elaboration of a draft packaging waste law in Ukraine.
- Discuss the Ukrainian framework laws, draft waste management legislation and draft packaging and packaging waste legislation.
- Exchange knowledge on the current status of the Ukrainian waste management system.
- Discuss expectations from the roadmap to establish an EPR system for the packaging waste in Ukraine.

Participants

The meeting will gather relevant governmental institutions, UNEP, private sector and CSOs in Ukraine.

The meeting will take place virtually via the Zoom platform. All registered participants will receive connection details to access the platform. English-Ukrainian simultaneous interpretation will be provided during the meeting.
