## Background

Resource Efficient and Cleaner Production (RECP) is used as an umbrella term for the application of preventive environmental strategies to achieve the triple aims of production efficiency, environmental management, and human development. For this, United Nations Industrial Development Organization (UNIDO) has developed an RECP methodology which is used by enterprise specialists and experts in the field of environmental management to identify sources of losses for all types of resources used within an enterprise, identify the root causes of such losses, and develop and assess the feasibility of activities to reduce or completely eliminate the losses. This builds national capacities, fosters dialogue between the industry sector and Government, and facilitates investments for the transfer and adaptation of Environmentally Sound Technologies.

United Nations Industrial Development Organization (UNIDO) supports to the National Implementing Partner (NIP) Energy Efficiency Centre Georgia for implementing the project on “Resource Efficient and Cleaner Production and Eco-Innovation among SMEs” in Georgia. (for more information visit: [www.recp.ge](http://www.recp.ge)). The objective of the project is to promote more efficient use of resources (energy, materials and water) and reduce risks to the environment and human health in Georgian enterprises. The project is a component of the regional program European Union for Environment (EU4Environment) implemented in the Eastern Partnership Countries.

The work on Resource Efficient and Cleaner Production also covers other activities, including:

- RECP Networking and Institutionalization
- RECP Clubs & Industry Demonstrations
- Circular Economy & Waste Management
- RECP Awareness & Knowledge Management and Capacity Building
- Introducing EU Single Market for Green Products: Product Environmental Footprint Methodology

The main component of the project is the establishment of so-called RECP Clubs consisting of manufacturing enterprises in different regions of Georgia. The RECP Clubs bring together small and medium sized enterprises (SMEs) and take them jointly through an intensive training and coaching programme, leading to a customized RECP action plan upon the completion of the Clubs' activities. For them, training in the RECP methodology modules was conducted over a period of four months. The Club training modules were organized in the following thematic areas: business environmental profile, energy, water and wastewater, materials and waste, chemicals and chemical waste. Then, the RECP action plan was developed by the SMEs, with the support of the RECP experts. The identified measures will the Club member companies to save energy, water and materials, reduce their negative impact on the environment and human health, increase profit, improve compliance with the Georgian environmental legislation, and increase their access to financial resources in order to invest in cleaner technologies. Upon the completion of the training programme and the submission of the RECP action plans, each Club member is awarded with a certificate, attesting its participation and contribution within the RECP Clubs programme.

## Event objectives

The event focuses on the following key objectives:

- Raising awareness among participants and key stakeholders on the “Circular Economy and New Growth Opportunities” Component of the “EU4Environment” Action in Georgia, and discussion of the achieved progress
