Green growth indicators framework

2009: Green Growth Declaration

2011: OECD Green Growth Strategy



Measurement framework to capture **4 areas of green growth:**

- **Productivity:** Are we becoming more efficient in using natural resources?
- **Natural assets base:** Is the natural asset base of our economies being maintained?
- **Quality of life:** Does greening growth generate benefits for people?
- **Policies:** How does greening growth generate economic opportunities?
- *no “one-size-fits-all” approach, adaptable to national context*

To pursue policies designed to promote green growth, governments need indicators to measure progress

 - **Water resources:** Support a more sustainable use of freshwater resources
 - **Environmental data:** Extend and improve the use of sound environmental statistics
- **Countries:** Armenia, Azerbaijan, Belarus*, Georgia, Republic of Moldova, Ukraine
- **Duration:** 2021-2024
- **Budget:** EUR 12,75 million (EU contribution: EUR 12 million)
- **Implementing partners:** UBA, ADA, OiEau, OECD, UNECE
- **Launch** event on 9 Feb 2022
