**Circular Economy in Practice: Consultations for the Validation of the Zestaponi and Rustavi Industrial Waste Mapping Report**  
**July 25<sup>th</sup>, 13:00 – 15:30, Zoom**

**Meeting objectives, expected outputs and outcomes**

This event focuses on the following key objectives:

- Present the main principles and benefits of Circular Economy to representatives of enterprises, decision-makers, and other stakeholders from the Zestaponi and Rustavi Municipalities
- Discuss the results from the waste mapping exercise in order to receive feedback from key stakeholders from Zestaponi and Rustavi. The discussion will focus partly on the results of the exercise, and partly, on how to optimise the process to the benefit of other regions and countries wishing to undertake waste mapping activities

- Discuss the benefits and opportunities related to Circular Economy and Industrial Waste Mapping for the manufacturing enterprises of the Zestaponi and Rustavi Municipalities.

The outputs of this consultation will include a validated IWM Report for the Municipalities of Zestaponi and Rustavi (with suggestions on how the recommendations could be implemented to introduce CE practices for the businesses located there). It will also provide recommendations on the implementation of the IWM methodology in other regions of Georgia and other Eastern Partner (EaP) countries. A draft guide on IWM implementation in the EaP region will also be presented to collect feedback.

### **Participants**

The list of participants for the validation meeting consists of representatives from the Zestaponi and Rustavi Municipalities, industrial enterprises located in the two regions, local and national authorities and agencies, non-governmental organizations and experts from Georgia, as well as representatives from UNIDO and SWECO.

The organizers of this event are UNIDO, REC Caucasus and SWECO.

### **Practical Information**

The event will be organized on July 25<sup>th</sup>, 2022, 13:00 - 15:30 (Tbilisi time, GMT +4). The event will be delivered online, using the Zoom platform. It will include presentations and discussions among the participants. The event will be hosted in both Georgian and English, and simultaneous interpretation will be provided.

### **Background**

The event: Circular Economy in Practice: Consultations for the Validation of the Zestaponi and Rustavi Industrial Waste Mapping Report is held within the framework of the “Circular Economy and New Growth Opportunities” Component of the EU- funded “EU4Environment” Action. Its purpose is to present the main principles and practices of Circular Economy and to give the representatives of the enterprises from Zestaponi and Rustavi the opportunity to discuss application strategies.

Waste management is comprised of the activities and actions required to manage waste from its generation to its final disposal. This includes the collection, transport, treatment and disposal of waste, together with the monitoring and regulation of the waste management process and waste-related laws, technologies, and economic mechanisms. An efficient waste management system creates an increased business value. This contributes to the sustainability of manufacturing industries and the promotion of economic opportunities.

The overall objective of waste mapping is then to identify, assess, and map waste streams of manufacturing enterprises in order to develop options for improving resource efficiency and the circularity of materials and by-products in the economy.

In Georgia, the Regional Environmental Centre for the Caucasus (REC Caucasus) supports UNIDO in implementing activity three, “Circular Economy and Waste Management” of the EU4Environment Action Component on “Circular Economy and New Growth Opportunities”. With direct guidance from SWECO, an international partner of UNIDO on introducing the Circular Economy practices, an IWM exercise was implemented in two municipalities in Georgia, from March 2021 to July 2022. This event will now review the results of the IWM exercise,

validate the assessed data and provide a platform for the region's decision-makers to engage in planning exercise and implement the given recommendations. It will also serve as a means to promote and apply the IWM methodology in other regions of Georgia, specifying the concrete steps necessary for conducting such an exercise. A draft regional guide describing the steps for introducing IWM in the EaP region will also be presented and discussed at this event.
