#### Meeting objectives, expected outputs and outcomes

- To present findings from each RECP n-plant assessment report
- To summarize the general outcomes and experience from the RECP assessments
- To conclude the RECP Demonstration Project with ways forward for both the RECP trainees and the assessed companies in Azerbaijan.

This training session shall include both presentations as well as discussions and feedback on the strategies needed to communicate, present, and critically examine the assessment's outcomes in order to facilitate the next steps that could be taken by each company's management. This is an important approach as the management's acceptance or rejection of the RECP proposal depends, to some degree, on the level of professionalism, knowledge, and delivery of findings for the identified RECP measures.

This training session is the final part of the RECP learning process. Here, the trainees will get the opportunity to learn from the experience of other groups and exchange views from the consultations. A session will also be dedicated to wrapping up, followed by comments and feedback, other opportunities identified during the assessments, RECP techniques and so on.
