The major goal of the NFERP

To ensure the country's needs in forest products/services in order to increase resilience to climate change in the long term through conservation and development of Moldova's forest resources

In terms of maintenance and continuity of national forestlands, the NFERP will carry out extensive tree/shrub planting and rehabilitation/promotion of forest vegetation on at least 145 (100) thousand ha for a period of 10 years (2023-2032)















Expected results by the end

- at least 15% forest expansion (13,4% now) of the country's territory
- 10% production increase compared with existing potential
- new forest plantations (110K ha) and rehabilitated forest (35K ha)
- decreased forest fragmentation index by 0.75 units
- reduced eroded/degraded lands and strengthened water envelope
- created jobs for 14.2 thousand people
- community & private forest sub-sectors promoted/developed















Specific objectives (5) structured in measures (16) split out into many actions

- SO1 -- Development and expansion of the national forest ground
- SO2 -- Strengthening forest reproductive material production capacity
- SO3 -- Sustainability of planted/rehabilitated forest vegetation
- SO4 -- Improving regulatory and institutional framework for forest management
- SO5 -- Forest guarding regime
