Monitoring public awareness and attitudes provides important information to understand the perceived effectiveness of the policies, and their perceived distributional impacts on lower-income households (inequality concerns).

Drawing on ongoing work in countries² and at the OECD³, the following questions will be discussed:

- How does the understanding of and attitudes toward environmental policies vary across countries?
- What are some of the methods for measuring people's perceptions, awareness, and attitudes?
- What are the key determinants of people's acceptance of and support for environmental policies?

Item 5. Implementing, disseminating and monitoring the Council Recommendation on environmental information and reporting

The new consolidated Recommendation on Environmental Information and Reporting was adopted by the OECD Council on 8 June 2022 at its meeting at Ministerial level (MCM).
