Background

The **High-Level National Round Table "GREEN ECONOMY - Made in Moldova"** is organized within the EU-funded EU4Environment Green Economy programme (as follow-up to the EU-funded "Greening Economies in the Eastern Neighbourhood" (EaP GREEN) programme that ended in 2017). EU4Environment is jointly implemented by EC, OECD, UNECE, UNEP, UNIDO and the World Bank and coordinated by the Ministry of Environment of the Republic of Moldova and the Ministry of Economy of the Republic of Moldova. An important component of EU4Environment is supporting Green Economy ownership, policy coherence and cross-sectorial coordination in Moldova and the Eastern Neighbourhood region.

The organization of the High-level National Round Table for the promotion of Green Economy is coordinated by the Inter-ministerial Working Group on Sustainable Development and Green Economy (also acting as the EU4Environment National Implementation Committee), co-chaired by the Ministry of Environment of the Republic of Moldova and Ministry of Economy of the Republic of Moldova. The event is organized in partnership with the Chamber of Commerce and Industry of the Republic of Moldova and the Public Association EcoContact, with support from UNEP within EU4Environment.

The **first** Round Table was organised in 2016 with support of the EaP GREEN programme, consecutive meetings (**second**, **third and fours**) took place yearly, the **fifth** event took place on 31 January 2020 at Moldexpo in person and the **sixth** organized online on 29 January 2021 (with more than 200 participants from Moldova and EaP countries online, with VIP participation from UNEP, OECD, Governments of Moldova, Ukraine, Georgia, Armenia etc and 50 000 persons reached).

Meeting objectives, expected outputs and outcomes (TBC)

- Promotion of the Green Economy Concept at the highest political level in Moldova, in all social-development sectors of the country, attracting the private sector, development partners, NGOs, media and the general public;
- Promotion of European Green Deal objectives and priorities in Moldova;
- Presentation of the contribution of the EU4Environment programme to the promotion of the Green Transition of Moldova;
- Conducting of a special information and training session on eco-labelling;
- Increasing awareness of stakeholders from businesses, governmental agencies and the general public on the application and benefits of the Green Economy and Circular Economy principles for sustainable economic development.

Participants

Invited participants to the Round Table include representatives from governmental agencies of the Republic of Moldova (MoEnv, MoEc, ODA), EUD, EU4Environment Green Economy IPs, NACs and beneficiaries, EU4Environment Water and Data, EU4Climate, international organizations, embassies, businesses and enterprises / private sector, academic sector, environmental NGOs and experts, mass-media from Moldova.
