



Conserving Emerald Sites in the Republic of Moldova: An Awareness-Raising Event on Management Plans and Conservation Measures

Summary record

21 July 2023 (10:00 – 16:00, Chisinau time)

















Summary of the presentations and discussions

An awareness-raising event was organized as a part of the EU4Environment Program sub-component 4.1, which is led by the World Bank and aims to support the protection of biodiversity and natural ecosystems, particularly advancing the establishment and management of the Emerald Network in the Eastern Partner countries. The objectives of the awareness-raising event were to:

- Consult the methodology for developing the unified management plans that provide clear and specific conservation objectives to promote the effective replication of conservation efforts nationwide.
- Address conservation measures, roles, responsibilities, and current needs using the Codrii Emerald site as a case study.
- Solicit feedback from stakeholders on improving legal and institutional aspects related to the Emerald Network Management in Moldova.

The event started with opening remarks by Ms. Veronica Josu, a consultant in the biodiversity division, of the Ministry of Environment. Ms. Josu provided an overview of the current situation and updates regarding the Emerald Network in the Republic of Moldova. She also discussed the main milestones and achievements regarding policy and institutional aspects, including the planned establishment of a dedicated Agency for the management of Protected Areas under the Ministry of Environment. Additionally, she highlighted the importance of legal framework improvement, institutional capacities, and conservation measures.

The second speaker was Mr. Aurel Lozan, country activity coordinator of the World Bank. He emphasized the significance of protecting species for the preservation of ecosystems. He also addressed the importance of proper management and conservation of protected areas, including the involvement of local authorities.

The host of the event, Natural Reservation "Codrii," delivered a welcoming speech and highlighted the main challenges currently existing in the Protected Area. These challenges include species assessment and research, as well as the fact that some species no longer persist on the Emerald site within the Reservation.

All speakers emphasized the importance of Emerald sites for biodiversity conservation. The meeting aimed to explore strategies for their effective management and preservation.

One of the highly anticipated presentations was on the methodology for developing unified management plans. The environmental expert, Mr. Ion Marin, highlighted that most of the Protected Area's administration, including research institutions, expressed the need for a methodology that would guide the developers of the management plans in elaborating unique formats. The methodology included each

component necessary for the management plans, along with details of why such components are necessary and what information should be described.

During the presentation, the aspect of mapping and zoning of the Emerald sites, Protected Areas, etc., was discussed to facilitate management, information, economic, and agricultural activities. The expert emphasized the need to include information on the species existing on the Emerald sites to develop proper conservation measures for them.

The participants provided a set of recommendations and debated some of the methodological provisions. It was agreed that the document would be shared with participants after the event for better consultation.

During the presentation by Mrs. Victoria Covali and Mr. Theodor Glavan, a discussion and set of questions arose. The following are some of the key points discussed:

Emerald Sites Overview: It was highlighted that there are currently 61 approved Emerald Sites in the Republic of Moldova. The participants emphasized the need to elaborate management plans and create institutions to oversee the conservation efforts for these sites. Additionally, it was mentioned that when the assessment of the Emerald sites is made, it will be decided if one management plan can be made for multiple sites, for example, if they have the same habitat/species.

Partnership and Collaboration: Mr. Lozan stressed the importance of protecting species for the preservation of ecosystems. He mentioned ongoing projects in collaboration with the Netherlands, Austria, and Ukraine, which can provide additional funding opportunities for biodiversity protection.

Presentation of the Draft Management Plan for Emerald Sites: The presentation highlighted the key factors that should be considered while formulating the management plans, including socio-economic factors, population numbers, activities within the area (economic, touristic, and recreational), potential threats, objectives, and activity plans.

Discussion on Site Borders and Administration: There was a debate on how to identify the borders of the Emerald Sites and determine the responsible administrators.

Opinion 1: Some suggested that "Codrii Moldovei" should be the administrator.

Opinion 2: Others proposed that the "Agency for Protected Areas" should be responsible for administration.

Terminology and Invasive Species: The audience discussed the terminology used to describe invasive species. To ensure clarity, it was suggested that the language used in laws and regulations should be accessible to all, including local public authorities.

Unified Informational System and Monitoring: The need for a unified informational system and a plan for monitoring the Emerald Sites was emphasized. Government approval for such a plan was deemed necessary to facilitate effective conservation efforts.

Conservation Measures and Silvicultural Implications: Participants agreed that conservation measures should focus on preserving habitats rather than individual species directly. They highlighted the

importance of accounting for environmental changes and implementing mechanisms for eco-systemic compensations. Controlled activities like fishing, hunting, and tourism were also discussed to strike a balance between conservation and human needs.

Wildlife Population Monitoring: The need to learn from Romania's experience in site administration was highlighted.

Digitalization of Information and Communication: Participants discussed the challenges of digitalizing information and effectively informing the population. These issues will be addressed in upcoming reforms, which aim to align Moldovan laws and practices with EU standards.

Emerald Zones and Protected Areas: There was a discussion on whether Emerald Zones are considered scientific or protected areas. Participants suggested simplifying the divisions between different types of zones to avoid unnecessary complexity.

Conclusion:

The event concluded with a collective understanding of the importance of conserving Emerald Sites in the Republic of Moldova. The participants recognized the need for effective management plans, public awareness, and collaboration among various stakeholders to safeguard these valuable ecosystems and their species.

The representative of the Ministry of Environment highlighted the importance and high quality of the documents submitted by the project, specifically the Road Map, which will serve as a guiding tool at the national level for advancing the Emerald Network in the Republic of Moldova through proper management, conservation measures, legal modification, institutional capacities, and training capacities.

The participants expressed their interest in participating in future events organized as part of the project to gain experience and share expertise related to the Emerald sites, species, habitats, and ecosystems.
