

Guarantee the long term survival of the species of Resolution No. 6 (1998) and Habitats of Resolution No. 4 (1996) by creating a fully implemented Emerald Network of Areas of Special Conservation Interest.

Overcoming Challenges

Implementation challenges:

Phase I

• Getting the necessary scientific information on species and habitats concerned

Phase II

 Keeping the evaluation cycle active by regularly submitting reviewed and updated Emerald Network databases

Phase III

- Creating and implementing management plans for each site
- Ensuring an efficient Legal framework
- Ensuring Stakeholders engagement
- Monitoring management implementation and species and habitat response

Phase I and II:

The Emerald Network Evaluation Cycle: "the engine for making progress"


Phase III:

Develop and implement management plans and monitor the efficiency

Development of a Roadmap

- Structure and plan the actions according to the 3 phases within a certain time frame (e.g. Up to 2030)
- Individualise the actions with timebound targets (specific and realistic)
- Best to follow the indexes as calculated in the Emerald Network Barometer
- Define responsibilities and ensure proper funding







EU4Environment Green Economy in Eastern Partner Countries

Possible actions for each phase

Phase I

- Ensure availability of high quality data for species and habitats
- Ensure regular updates of the Emerald Network Sites database

Phase II

 Mediate the organisation of Biogeographical seminars and ensure the adoption of the Emerald Network Sites

Phase III

- Adopt general guidelines for the development of management plans
- Plan, develop and implement a management plan for each site

Foresee non-phase related actions: e.g. Legal framework, stakeholders involvement etc.
