






Net Zero Accelerator: From Global Commitment to Local Action

- GCCA committed to Net Zero by 2050 in line with Paris Agreement.
- Launched "The GCCA 2050 Cement and Concrete Industry Roadmap for Net Zero Concrete" in 2021.
- Roadmap outlines decarbonization levers and global sector pathway.- Acknowledged by UN Secretary General, Antonio Guterres.
- GCCA developed Net Zero Accelerator program for action.
- GCCA seeking partnerships for local Net Zero Accelerator Program rollout.


GCCA 2050 Roadmap

In 2021 GCCA launched and commit to the GCCA Net Zero 2050 Cement and Concrete Roadmap in line with **Paris Agreement and 1.5 degree scenario**.





GCCA 2050 Roadmap

The cement and concrete net zero pathway covers the full value chain, identifies **7 key decarbonization levers** and technologies to reach Net Zero by 2050 with intermediate 2030 commitment.

- Initial roadmap draft to be presented at COP29 in November.
