## The RECP methodology

**Resource Efficient and Cleaner Production (RECP)** is the integrated and continuous application of preventive environmental strategies to **processes, products, and services** to increase efficiency and reduce risks to humans and the environment. RECP is all about producing with fewer resources while minimizing environmental impacts and increasing overall productivity. For **Small and Medium-sized Enterprises (SMEs)**, the RECP methodology is an effective means to lower production costs whilst improving the SMEs' competitive advantage and applying environmentally friendly practices. RECP is also an effective tool to introduce and promote Circular Economy principles among SMEs.

"UNIPRO (UNICO) Production" LLC specializes in the production of furniture, including doors, wardrobes, wooden wall coverings, kitchen furniture, wooden stairs, tables, chairs, benches, reception desks, and plinths. All furniture products are manufactured in-house, using a combination of handcraft and modern equipment to ensure high quality and meet customer expectations. The largest segment of operations involves cutting, processing, gluing, sanding, priming, and painting various types of raw wood materials. Motivated to address production costs, the company participated in the RECP Demonstration Project under EU4Environment (2019-2024). This publication details the company's experience reported after the assessment exercise conducted in 2024.

# The project approach

The RECP team evaluated the production site and identified several options, with the following recommendation being prioritised by the company staff:

**RECP Option 1. Utilising wood waste:** As a low-difficulty measure, the RECP team recommended sorting and repurposing wood waste generated from the cutting and assembling of furniture. Currently, wood products require manual sorting by composition, and the cost of the final raw material is approximately ten times lower than the overall processing cost. Consequently, much of this material becomes general waste, with only 20% being incinerated. The remaining material is not recycled or repurposed for construction materials or other uses. Implementing a more efficient sorting and recycling process could significantly improve the recovery and reuse of this valuable material.
