

## Natural resource management through community engagement

#### **Ecotourism Management Plan Template Tool for Armenia:**

• A European-standard-aligned ecotourism management manual that defines cooperation models, clarifies stakeholder roles and shared benefits, promotes PA-business joint initiatives for conservation through standardized products, and includes MEET Network criteria and a roadmap for protected areas' accession.

### Eight Pilot Ecotourism Packages for Dilijan, Goris, Vardenis, Kapan, Ijevan, Tumanyan, Alaverdi, and Vanadzor communities:

• Municipality-specific ecotourism packages—grounded in the developed guidelines and best practices from RESILAND and GPS TTA—that define target segments and channels, signature attractions, physical and digital infrastructure, and indicative pricing for marketable trips.

#### **Capacity Building Events:**

• 8 training/demonstration events (communities, PA managers, tourism, forest economy), plus 2 local info sessions (FMP and SPMP), and 1 state-level event on MEET Network benefits and accession roadmap.



## Natural resource management through community engagement

Ecotourism Management Plans (Imereti & Samegrelo-Zemo Svaneti, Georgia) for eight forestry districts: Baghdati, Kharagauli, Sachkhere, Kutaisi, Vani, Tsalenjikha, Chkhorotsku, Martvili.

#### **Key activities:**

Spatial & Contextual Analysis:

- Municipal-level mapping of attractions, existing offers, access routes, and integrable infrastructure
- Assessment of constraints (environmental threats, infrastructure gaps, land-use conflicts)
- Integration of forest/municipal boundaries, biodiversity hotspots, Emerald Sites, protected areas, and relevant environmental data

Stakeholder Engagement & Participatory Assessment:

- Interviews and focus groups with municipal officials, local providers, and communities
- Assessment of engagement, livelihood benefits, and opportunities to expand ecotourism while protecting natural resources
- Local information events in target municipalities

#### Plan Development & Validation:

- Draft tailored plans per district combining spatial and stakeholder findings
- Actionable recommendations balancing conservation and sustainable development, enhancing ecotourism and community benefits
- Final validation workshop with stakeholder feedback; hybrid format with international experts as needed








- Support Nature Restoration and Enhance Community Benefits in central hilly plateau (=Codii region) (at least 500 ha of natural/spontaneous vegetation on community-owned land formalized)
- Report "Moldova Nature Restoration Potential Analysis" (supporting future investments and programmatic pathways for ecological recovery)





- Disseminating lessons learnt from community engagement opportunities in NRM in Ukraine








